3. Jr. Varsity are students in the 5<sup>th</sup> and 6<sup>th</sup> grades born after the 31<sup>st</sup> day of December 1996. Varsity are students in the 7<sup>th</sup> and 8<sup>th</sup> grades born after the 31<sup>st</sup> day of December 1994.
4. Other rules and regulations as established by the Cheerleading Coordinator with approval by the current Football Board will be available upon registration.

**RISKS**

I/We fully understand and acknowledge that:
